



## Privacy Notice – Website

Ipsen (“We”) are committed to protecting and respecting your privacy.

This Privacy Policy describes the ways in which Personal Information about individuals (“Users”) who use this website (the “Website”) may be collected, stored and used by Ipsen Limited, 190 Bath Road, Slough, Berkshire SL1 3XE (“Ipsen”), the data controller.

THIS PRIVACY POLICY MAY PERIODICALLY CHANGE, BE MODIFIED, OR OTHERWISE UPDATED WITHOUT PRIOR NOTIFICATION. However, your Personal Information (as defined below) will always be handled in accordance with the Privacy Policy that was in effect at the time of collection.

### 1. Personal Information Collected:

Ipsen may collect personal information when you register to become a User or otherwise contact us through the Website, including your name, e-mail address, city and country of residence (“**Personal Information**”). If you wish to receive information from Ipsen/contact Ipsen, these categories of Personal Information are mandatory.

When you register as a User, we clearly label which information is required for registration, and which information is optional and may be given at your discretion.

### 2. Uses of Personal Information:

By providing Personal Information you confirm that Ipsen may communicate with you regarding any requests or enquiries you submit through the Website and provide you with related support or service communications (e.g. password changes).

Your Personal Information will only be processed for the purposes of the legitimate interests pursued by Ipsen, namely having a better interaction with you.

Your Personal Information may be processed by service providers or companies affiliated with Ipsen in non-EU countries which may not ensure an adequate level of protection to Personal Information. To ensure your Personal Information is protected, Ipsen will, where necessary, ensure that the recipient has certified its adherence to the Privacy Shield, enter into data transfer agreements which include the EU Commission’s standard contractual clauses, or will adopt Binding Corporate Rules (BCRs) for transfers of Personal Information with the Ipsen Group. Such contract or BCRs can be made available upon your request

Your Personal Information will not otherwise be sold, shared or distributed to third parties without your consent, except where we are required to do so because of an applicable law, court order or governmental regulation, or if such disclosure is otherwise necessary in support of any criminal or other legal investigation or proceeding here or abroad.

### 3. Term of Retention of Your Personal Information

Your Personal Information is processed and kept for no more than three years from the: (i) the date of its collection or (ii) if later, the date of the last contact we have with you.

### 4. Security

Your Personal Information will be stored on secure servers and maintained strictly confidential. You are responsible for maintaining the secrecy of your unique password and account information.

### 5. Right of Access, Correction and Objection

You have a right to request access to and/or correction or deletion of your Personal Information, and to restrict and object to the use of your Personal Information. If you wish to contact us regarding our use of your Personal Information or exercise any of your rights regarding your Personal Information, please email us at **consent@ipsen.com**. If you contact us, please indicate the specific reason why you are contacting us and include a copy of a piece of identification (e.g., ID card, passport, driver's licence), subject to applicable legal requirements. Requests to delete personal data will be subject to any applicable legal and ethical reporting or document filing or retention obligations imposed on us. In this case, you will be informed about this and your Personal Information will only be retained to meet those purposes.

### 7. Cookies

This Website uses anonymous analytics, including cookies generated by Google Analytics. Cookies are small data files which are placed on your computer, smartphone or other device. Cookies are stored on the hard disk of your device without any risk of damaging it.

Cookies allow us to collect automatically certain user data during your use of the Website, such as:

- The IP address of the User (this address, which allows access to the Internet, is assigned to the device of the User by the Internet service provider and the information, which changes according to the session of the User, is not directly personally identifiable);
- The date and time of the visit of the User on the Website;
- The operating system of the User's device as well as its browser;
- How the User accesses the Website.

The Website uses several types of cookies:

**Strictly necessary cookies:** These cookies are essential to enable you to move around the Website securely and use its features.

**Performance cookies:** These cookies collect information analytics about how visitors use the Website, for instance which pages visitors go to most often, and if they get error messages from the Website. This includes analytics cookies generated by Google Analytics.

These types of cookies do not collect information that directly identifies Users, but instead make use of numbers and codes. This information is solely used to administer the Website and improve the User experience. The information is not used to create profiles on Users or to provide targeted advertising.

Ipsen will retain the data collected (the cookie identifier) for no longer than thirteen months.
